This Amendment No. 5 to Schedule 13D (this "Amendment") relates to shares of common stock, par value \$0.01 per share (the "Common Stock"), of Lands' End, Inc., a Delaware corporation (the "Issuer"). This Amendment amends the Schedule 13D, as previously amended, filed with the Securities and Exchange Commission by ESL Partners, L.P., a Delaware limited partnership ("Partners"), SPE I Partners, L.P., a Delaware limited partnership ("SPE I"), SPE Master I, L.P., a Delaware limited partnership ("SPE Master I"), RBS Partners, L.P., a Delaware limited partnership ("Institutional Partners, L.P., a Delaware limited partnership ("Institutional"), RBS Investment Management, L.L.C., a Delaware limited liability company ("RBSIM"), CRK Partners, LLC, a Delaware limited liability company ("CRK LLC"), ESL Investments, Inc., a Delaware corporation ("ESL"), and Edward S. Lampert, a United States citizen, by furnishing the information set forth below. Except as otherwise specified in this Amendment, all previous Items are unchanged. Capitalized terms used herein which are not defined herein have the meanings given to them in the Schedule 13D, as previously amended, filed with the Securities and Exchange Commission.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended and supplemented as follows:

"In open market purchases on September 24, 2015, September 25, 2015, September 28, 2015 and September 29, 2015, Mr. Lampert acquired an aggregate of 460,219 shares of Common Stock for aggregate consideration of approximately \$12,342,504 (excluding commissions) using personal funds."

Item 5. Interest in Securities of the Issuer.

Item 5 is hereby amended and restated in its entirety as follows:

"(a)-(b) Each Reporting Person declares that neither the filing of this statement nor anything herein shall be construed as an admission that such person is, for the purposes of Section 13(d) or 13(g) of the Act or any other purpose, the beneficial owner of any securities covered by this statement.

Each Reporting Person declares that neither the filing of this statement nor anything herein shall be construed as an admission that such person is, for the purposes of Section 13(d) or 13(g) of the Act or any other purpose, (i) acting (or has agreed or is agreeing to act) with any other person as a partnership, limited partnership, syndicate, or other group for the purpose of acquiring, holding, or disposing of securities of the Issuer or otherwise with respect to the Issuer or any securities of the Issuer or group with respect to the Issuer or any securities of the Issuer.

As of the time of filing on September 30, 2015, the Reporting Persons may be deemed to beneficially own the shares of the Common Stock of the Issuer set forth in the table below.
