- Of the total number of RSUs, 29,412 vest on each of March 6, 2019 and March 6, 2020, and 29,411 will vest on March 6, 2021; 39,337 vest in three installments on May 1, 2018 (25%), May 1, 2019 (25%) and May 1, 2020 (50%); subject in each case to the satisfaction of vesting conditions, including continued employment.
